


ABOUT OUR ORGANIZATION...

During his 16-year judicial career, he served as a presiding judge for the Camden County Superior Court for 12 years. He served as presiding judge of the Camden County Superior Court's Civil Division for eight years, and was appointed as presiding judge of that

Court's Chancery Division. Prior to his appointment as presiding judge, he served as a judge in Camden County's family and criminal divisions. He is presently affiliated with Parker McCay and focuses his practice on alternative dispute resolution, and complex litigation management. ETS MEMBER RESEARCHES CELEBRITY ESTATES

When I first entered law school I never realized my guilty pleasure of reading celebrity magazines would come in handy. I was thrilled to begin researching celebrity estates; everything from frozen heads, to forged signatures, to disfavored offspring. Being a member of the Estates and Trusts Society afforded me the opportunity to work as a research assistant for Russell Fishkind, a partner in the Personal Wealth, Estates and Trusts Department at Saul Ewing, LLP. Fishkind's book on celebrity estates demonstrates the importance of having an accurate and up-to-date will. Readers will be attracted by the celebrity glamour and scandalous stories, but they will also be able to see how big an impact estate planning can have on their own lives. By writing about the estates of the rich and famous, Fishkind is able to show readers how important wills are on a large scale. When millions of dollars are at stake, litigation can go on for years and families

can be torn apart. While most of us don't have millions in the bank, or royalty income pouring in each month, we work hard for what we do have. My research shows how even the smallest uncertainty in your will can give rise to major problems later on. It was a great opportunity to study the law, while stepping away from the sometimes stuffy rules of legal writing. (Fishkind asked us to write in the style of *People Magazine*, rather than using a law journal format). To me, this project was a reminder of how every area of law has its intrigue; sometimes you'll be pleasantly surprised at where your legal training will take you.
